**NOTE: ARTICLE V, SECTION 2** (1) NO SIGN SHALL BE ERECTED WHERE BY REASON IT CAN BE CONFUSED WITH ANY TRAFFIC CONTROL SIGN, SIGNAL OR DEVICE. (2) NO SIGN SHALL MAKE USE IN SUCH A MANNER AS TO INTERFERE WITH, MISLEAD OR CONFUSE TRAFFIC. (3) NO ILLUMINATED SIGN SHALL BE PERMITTED WITHIN TWENTY-FIVE (25) FEET OF PROPERTY IN ANY RESIDENTIAL AREA UNLESS THE ILLUIMINATION OF SUCH SIGN DOES NOT SHINE OR REFLECT LIGHT INTO SUCH PROPERTY. (4) NO BUSINESS OR ADVERTISING SIGN SHALL BE ERECTED TO EXCEED FIFTY (50) FEET IN LENGTH NOR EXCEED THE BUILDING HEIGHT. (5) ALL OUTDOOR ADVERTISING STRUCTURES SHALL BE ERECTED IN CONFORMITY WITH THE SIDE AND REAR YARD REQUIREMENTS OF THE DISTRICT IN WHICH IT IS LOCATED AND SHALL BE SET BACK FROM THE STREET RIGHT-OF-WAY LINE AS TO NOT BLOCK THE VIEW. (6) TEMPORARY SIGNS SHALL NOT BE ERECTED, FIXED TO ANY POLE, TREE, STONE, FENCE, BUILDING OR STRUCTURE WITHIN THEIR RIGHT-OF-WAY OF ANY STREET, AT INTERSECTIONS OF ANY STREET TO OBSTRUCT VISION OR BE CONFUSED WITH ANTY TRAFFIC SIGN. TEMPORARY SIGN SHALL NOT EXCEED ONE HUNDRED (100) SQUARE FEET IN AREA. (7) A TEMPORARY SIGN SHALL NOT BE SUSPENDED ACRESS PUBLIC STREETS WITHOUT PERMISSION OF THE CITY COUNCIL. (8) PROFESSIONAL SIGN FOR HOME OCCUPATIONS SHALL NOT EXCEED FOUR (4) SQUARE FEET AND NOT LOCATED CLOSER THAN TWENTY (20) FEET OF STREET RIGHT A WAY. (9) BULLETIN BOARD OR SIGN NOT TO EXCEED FORTY (40) SQUARE FEET APPERTAINING TO THE LEASE, HIRE OR SALE OF BUILDING AND WILL BE REMOVED AS SOON AS PREMISES LEASED, HIRED OR SOLD.

**PENALTY FOR VIOLATION:** Any person or corporation who shall violate any of the provisions of this zoning ordinance or fail to comply thereafter with any of the requirements thereof, shall be Guilty of a misdemeanor and shall be liable to a fine of not more than one hundred dollars (\$100.00). Each day such violation is permitted to exist shall constitute a separate offense.

**Notice:** This permit becomes null and void if work or construction authorized is not started within 6 months or if construction or work is suspended or abandoned for a period of 6 months at any time after work is started.

If application is granted, I agree to notify the Building Inspector or his representative when work is be started, and request a site inspection.

The granting of a permit does not presume to give authority to violate or cancel the provisions of any other state or local law regulating construction.
